

Die Haltung von Greifvögeln und Eulen in Kärnten

KÖPF R., 1996: In Übereinstimmung mit den jagdgesetzlichen Bestimmungen sind alle Greifvögel und Eulen in Kärnten ganzjährig jagdlich geschont. Die Landesregierung kann Ausnahmegewilligungen für wissenschaftliche Forschung und Lehre, die Falknerei, Zucht, Schaubetriebe oder Pflegefälle erteilen. Die bisherigen Erfahrungen bei der Durchführung der gesetzlichen Regelungen in Kärnten und die Zusammenarbeit mit den Behörden anderer Bundesländer werden veranschaulicht.

KÖPF R., 1996: Keeping birds of prey and owls in Carinthia.

In accordance with the game-law regulations all birds of prey and owls in the province of Carinthia are preserved during the whole year. Keeping them for scientific research, for practising falconry and for exhibition purposes requires the dispensation from the general keeping prohibition. The responsible authority is the Carinthian Provincial Government, which has to examine the legitimacy of the origin of the bird; and for this purpose to establish whether the applicant can prove the necessary keeping reliability, and whether the scientific keeping requirements are being met for the respective species. The marking of the birds of prey and owls kept in Carinthia is accomplished by means of WAA leg-rings in accordance with CITES for the protection of species. Breeding of birds of prey and owls also requires a keeping permission and is controlled by the Office of the Carinthian Provincial Government independent of the respective purposes (i.e. scientific research and study, falconry and releasing purpose for preservation reasons, exhibitions offering expert information). CITES rings are put on the captive-bred birds to mark them as soon as possible. The control and application of the rings is carried out at least once a year. The Nature Protection Department of the Carinthian Provincial Government responsible for the protection of species is continuously informed on the status of captive breeding birds of prey by means of the application of the rings. In spite of the differing game-law regulations of the Federal Provinces it is necessary to make an agreement on information about the origin of individual birds of prey and owls.
