To ensure the timely preparation of the conference proceedings please submit your contribution (each talk and/or poster) or an extended abstract thereof.

Papers

You may provide a more detailed account or a summary of your presentation in the conference volume, but all presentations (talk or poster) should be represented in the conference volume. The minimum format would be a short, concise summary that covers all relevant aspects of your work. Your contribution for the conference volume must always include more information than was required for submissions in the conference call.

Utilization rights

To enable you to also publish your presented work elsewhere, we grant you free access to the information contained in your conference volume publication.

Language

English only

Guiding theme

Dynamics and conservation in protected areas - challenges for research and management.

Please take into account the relevant aspects of the conference focus 2013:

Dynamics and conservation in protected areas under conditions of global change and the need to protect diversity.

- Do protected areas achieve the objectives defined for the protection of processes, functions and diversity and where are the limits?
- What are currently the most relevant research priorities, research questions, methods and recent results regional and supra-regional, short- and long-term?
- Long-term ecosystem research: What do we know from science and practice (e.g. conservation monitoring, indicators, LTER, ...)?
- Where do protected areas, their regions and their networks currently stand regarding research and management?

Number of characters

20.000 characters max. (including spaces, title, abstract, keywords, references, contact)

Structure

Title, author(s), abstract, keywords, introduction (research question(s), references to the guiding theme and to protected areas), methods, results, discussion, conclusion (referring to the research question(s) and the guiding theme, recommendations, future perspectives, open questions), references (listed in alphabetical order), contact (full addresses, incl. e-mail).

Manuscript

The manuscript(s) and all illustrations should be submitted as follows:

- Please send all content separately in file format as e-mail attachment(s)
 - text: Microsoft Word for Windows or .rtf
 - <u>pictures, illustrations</u>: .jpg or .tiff (at least 300 dpi for the size of 10 x 15 cm)
 - <u>tables, charts</u>: .xls or .jpg (at least 300 dpi for the size of 10 x 15 cm),
- refer to all tables, figures, pictures in the text in numerical order,
- All visuals must be printable in black and white. Please configure all charts and (GIS-)maps so that the used signatures are easy to differentiate and choose high-resolution photographs,
- Please provide the names of the copyright owners for each picture, diagram etc.,
- number all pages,

- do not use footnotes in the manuscript,
- cross-check all references carefully,
- Please note: all authors of the conference volume are fully responsible for the content and opinions expressed in their writings. The contributions will not be peer-reviewed.

In the text

Place the authors' last names (without initials) and the date of publication in parentheses (Braun 2008) or (Braun & Scott 2008) or (Braun 2008; Braun & Scott 2008). If there are more than two authors, please name only the first author and replace the co-authors with et al. (Braun et al. 2008).

List of all references

Last name, Initials Year. Title of article. Title of Journal (series number if necessary) volume number (issue number if necessary): page numbers. Town.
